Our goal is and always has been, to provide to you a safe and dependable supply of drinking water. Our water source is ground water.

We're pleased to report that our drinking water is safe and meets federal and state requirements.

Valley Grove Subdivision routinely monitors for constituents in your drinking water according to Federal and State laws. The following table shows the results of any detects in our monitoring for the period of **January 1^{st,} 2000 to December 31st, 2006.** For constituents that are not monitored yearly, we have reviewed our records for the last 5 years.

We have monitored for lead and copper, and all of our samples have been in compliance with the Lead and Copper Rule.

In the tables above and below you will find many terms and abbreviations you might not be familiar with. To help you better understand these terms we've provided the following definitions:

Parts per million (ppm) or Milligrams per liter (mg/l) - one part per million corresponds to one minute in two years or a single penny in \$10,000.

Parts per billion (ppb) or Micrograms per liter (ug/L)-one part per billion corresponds to one minute in 2000 years, or a single penny in \$10,000,000

Action Level - the concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Treatment Technique (TT) - (mandatory language) A treatment technique is a required process intended to reduce the level of a contaminant in drinking water.

Maximum Contaminant Level - (mandatory language) The "Maximum Allowed" (MCL) is the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal - (mandatory language) The "Goal" (MCLG) is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Picocuries per liter (pCi/L)-picocuries per liter is a measure of the radioactivity in water.

Our system had 2 violations. We failed to monitor for coliform in December of 2006. This is a monthly test, and no coliform were detected in November or January, so we believe the water was safe at the time we failed to sample. Our other violation was that the stat e did not receive the copy of the consumer confidence report that was mailed to them. They did receive the documentation form that was with the report, so we are not sure what happened to the report at their office.

We're proud that your drinking water meets or exceeds all Federal and State requirements. We have learned through our monitoring and testing that some constituents have been detected. The EPA has determined that your water **IS SAFE** at these levels.

All sources of drinking water are subject to potential contamination by constituents that are naturally occurring or are manmade. Those constituents can be microbes, organic or inorganic chemicals, or radioactive materials.

All drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. MCL's are set at very stringent levels. To understand the possible health effects described for many regulated constituents, a person would have to drink 2 liters of water every day at the MCL level for a lifetime to have a one-in-a-million chance of having the described health effect.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections.
